
Investment Policy and Objective

The fund aims to provide capital growth over the long term. The funds equity exposure will always exceed 80% of its net asset value. It may include liquid assets, equities, notes, property securities, preference shares, convertibles, interest-bearing, and non-equity securities. It can invest in participatory interests and other forms of collective investment schemes, and may from time to time invest in listed and unlisted instruments, in accordance with the provisions of the Act. The benchmark is the FTSE/JSE Capped Shareholders Weighted All Share Index.

Investor Profile

The fund is appropriate for investors who possess a high risk tolerance and seeks to maximize capital growth over a long-term investment horizon. The fund is not compliant with Regulation 28 of the Pension Funds Act.

The portfolio's performance numbers are calculated net of the TER expenses. The investment manager earns a portion of the service charge. No performance fees is charged on the fund.

Boutique Collective Investments adopted the ASISA Standard on Effective Annual Cost ("EAC"). The EAC measure allows you to compare charges on your investments as well as their impact on your investment returns prior to investing. BCI calculates the EAC as per the ASISA standard for a period of 3 years up till the most recent TER reporting period.
