Investment Policy and Objective

The fund aims to maximise income. The fund's equity exposure is limited to a maximum of 10% of its net asset value. It may include liquid assets, equities, notes, property securities, property related securities, preference shares, convertibles, interest-bearing, and non-equity securities. It can invest in participatory interests and other forms of collective investment schemes, and may from time to time invest in listed and unlisted instruments, in accordance with the provisions of the Act. The benchmark is the Stefi Composite Index. Over a one-year period, the fund targets CPI plus 1%.

Investor Profile

The fund is appropriate for investors who aim to maximise income over a short-term time horizon and are seeking higher returns than cash. The investor must be willing to tolerate low volatility of returns. The fund is compliant with Regulation 28 of the Pension Funds Act.

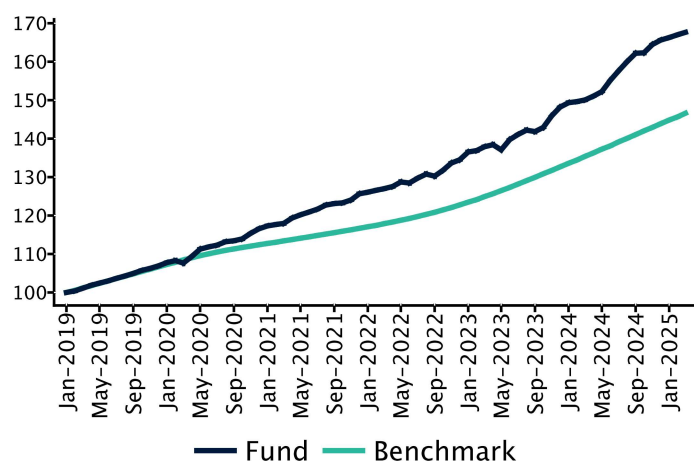

The EAC measure allows you to compare charges on your investments as well as their impact on your investment returns prior to investing.
